Department of Justice Grants Program Plan

Fiscal Year 2023 DOJ Program Plan

The Department of Justice offers funding opportunities to support law enforcement and public safety activities in state, local, and tribal jurisdictions; to assist victims of crime; to provide training and technical assistance; to conduct research and collect national statistics; and to implement programs that improve the criminal, civil, and juvenile justice systems. The DOJ Program Plan is a tool to help find potential funding opportunities (solicitations) from DOJ's grant-making Components, the Office of Community Oriented Policing Services (COPS), Office of Justice Programs (OJP), and Office on Violence Against Women (OVW). The Program Plan provides summary details of the funding opportunities each DOJ grant-making Component is expecting to release or has released in a particular fiscal year.

To Search, click Use Search Filters, enter the search criteria and then click Show. Click on any solicitation title for more information. From there click Results to return to your Search results or click Use Search Filters to enter new or refined search criteria. You can filter by the grant-making component or office (i.e., COPS, OJP program offices, and OVW), keywords, eligible applicant categories, and expected release date.

On the solicitation details page, the Opportunity ID will say "TBD" for any program that has not yet been published. For those that have been published, if you are interested in applying for funding, you can copy the Opportunity ID into the Search box on <https://www.grants.gov/>.

Peer reviewers consist of active or recently retired practitioners with on-the-ground experience responding to the crimes of sexual assault, domestic violence, dating violence, and stalking. Applying for DOJ Funding Tip Series

Submit Grants.gov Forms SF-424 and SF-LLL

The first step in the Department of Justice (DOJ) application process requires applicants to submit an initial application in Grants.gov. Applicants will complete and submit two standard government forms in their Grants.gov Workspace:

- Application for Federal Assistance (SF-424)
- Disclosure of Lobbying Activities (SF-LLL)

Once submitted in Grants.gov, the information from these forms will be transmitted to JustGrants where applicants will complete the remaining sections of their application. Applicants will be able to update information sourced from the SF-424, such as project title and funding request, in the JustGrants application. Completing an Application in JustGrants

The training and resources available on the [JustGrants Training: Application Submission](#) page will help you get ready to complete your application in JustGrants. Access the [DOJ Application Submission Checklist](#), [Application Submission Job Aid Reference Guide](#), and a new Application Mechanics eLearning video that contains step-by-step instructions on how to complete your application. These resources are available to help you through each step of the application submission process from start to finish.

New Enhancements to JustGrants

JustGrants is constantly improving its user experience for applicants. This year, JustGrants has included the following functionalities enabling users to –

- add up to three application submitters per application, and
- recall an already-submitted application prior to the deadline.

Applicants are also encouraged to attend an [application mechanics training](#), which is held every Wednesday from 2:30 to 4:00 p.m. ET. These virtual sessions walk users through the application submission process, and provide demonstrations of each JustGrants application section.

Onboard and Access JustGrants

Once JustGrants receives the initial application submitted in Grants.gov, prospective applicants will need to log in to JustGrants to complete and submit the full application.

For both new and returning users to JustGrants, [step 3 of the DOJ Application Submission Checklist](#) outlines what to expect when onboarding and accessing JustGrants. Every entity will have a unique JustGrants entity profile based on their SAM.gov unique entity identifier (UEI), which contains all Department of Justice (DOJ) applications and awards for that entity.

Accessing JustGrants: Existing Entities

If an entity already has a JustGrants account, the application submitter will find the draft JustGrants application waiting in their "Worklist" upon logging in. Entity users can also view applications within their entity profile.

Accessing JustGrants: New Entities

If you're new to JustGrants, your entity's System for Award Management (SAM) electronic business primary point of contact (E-Biz POC) and the individual identified in Section 8.F of the SF-424 will receive an email from DIAMD-NoReply@usdoj.gov with instructions on how to create an account in JustGrants.

How To Complete a Budget in JustGrants

A detailed budget proposal that documents every expected cost associated with a proposal is a critical piece of your application.

For specific budget instructions related to your application, applicants should first review the solicitation for further details. If a budget detail form is required, this [JustGrants training video](#) will provide instructions on how

to complete the form, and the [Application Submission Job Aid Reference Guide](#) will show you how to add the associated costs to your proposal.

The budget summary section of the budget detail form is the space where applicants review the breakdown of total project costs across any requested federal funding, match, or program income. For support in entering match and program income, be sure to review the [Budget Summary Matching Quick Reference Guide](#).

Submit Your Application in JustGrants

The final step to applying for Department of Justice (DOJ) funding is to submit your completed application in JustGrants. Every funding opportunity has a JustGrants submission deadline, and applicants are encouraged to submit in advance to provide ample time to address potential gaps or errors.

Check for Errors Early and Often

Every funding opportunity describes unique application requirements that then translate to your JustGrants application. Those requirements are generally marked by an asterisk, and users are prompted to address those requirements within each application section (when selecting the "Continue" button on each section). Users can also check for errors in the final section of the application on the "Certify and Submit" page. Successful Submission

Once your application has been successfully submitted, a confirmation message will appear at the top of the page, the application status will change to "Submitted," and users will receive an email confirming successful submission.

2. OVC FY 2023 Developing Future Victim Specialists to Serve American Indian/Alaska Native Victims of Crime

With this solicitation, OVC seeks to develop a workforce of victim service providers to serve American Indian and Alaska Native (AI/AN) victims of crime in isolated locations. By identifying and training prospective victim service professionals in, or from, the communities to be served, Tribal and Bureau of Indian Affairs (BIA) victim service programs will be better able to fill these positions in remote Indian Country and Alaska Native locations, and in turn ensure that victims in these locations get the services they need.

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the

community. With this solicitation, BJA seeks to support small and rural agencies in their efforts to combat violent crime.

4. BJA FY 23 Reimagining Justice: Testing a New Model of Community Safety –

With this solicitation, BJA seeks to fill a gap within OJP's current funding plan by seeding the development, implementation, and testing of new or innovative approaches to achieving community safety that are alternatives to a traditional enforcement model for communities experiencing a precipitous increase in less serious and lower-level crimes. This solicitation will fund applications proposing an innovative strategy or model to improve community safety, build trust, limit unnecessary involvement in the criminal justice system, and improve residents' perceptions of law enforcement and procedural fairness and legitimacy.

5. Victims of Human Trafficking in Native Communities (VHT-NC) Demonstration Program

The VHT-NC Demonstration Program funds organizations to build, expand, and sustain organizational and community capacity to deliver comprehensive services to Native American adults and children who have experienced human trafficking. The VHT-NC Demonstration Program is informed by a whole family approach that focuses equally and intentionally on services and opportunities for clients and their immediate family members living within their households.

6. Domestic Victims of Human Trafficking Services and Outreach (DVHT-SO) Program –

The Office on Trafficking in Persons (OTIP) within the Administration for Children and Families (ACF) is announcing funding for the Domestic Victims of Human Trafficking Services and Outreach (DVHT- SO) Program. The goal of the DVHT-SO Program is to fund organizations that will build, expand, and sustain organizational and local capacity to deliver services to domestic victims of severe forms of human trafficking as defined by the Trafficking Victims Protection Act (TVPA) of 2000, as amended through victim outreach, identification, case management, direct services, assistance, and referrals. Under the DVHT-SO Program, the following activities are required: 1) comprehensive case management and services to adults and children who have experienced human trafficking; and 2) outreach to increase identification of adults and children who have experienced sex and labor trafficking. The DVHT-SO Program is informed by a whole-family approach that focuses equally and intentionally on services and opportunities for individuals who have experienced human trafficking and their immediate family members living within their households. OTIP encourages community partnerships, meaningful engagement of individuals who have experienced human trafficking, and hiring qualified professionals from the communities being served under the DVHT-SO Program. Recipients will undergo a 12-month project implementation period to establish partnerships, on-board new staff, and develop a victim service protocol and a sustainability plan.

7. Family Counseling and Support for Lesbian, Gay, Bisexual, Transgender, Queer/Questioning, Intersex+ Youth and their Families –

The purpose of this program is to prevent health and behavioral health risks (e.g., suicide, depression, homelessness, drug use, HIV) and to promote well-being for LGBTQI+ youth in the context of their families/caregivers, cultures, and communities by establishing LGBTQI+ family counseling and support

programs and training providers on family counseling and support interventions. Eligible applicants are States and Territories (American Samoa, Guam, Marshall Islands, Micronesia, Northern Mariana Islands, Palau, Puerto Rico, Virgin Islands), including the District of Columbia; political subdivisions of States (i.e. county, city, state); Indian tribes, or tribal organizations (as such terms are defined in section 5304 of title 25); health facilities, or programs operated by or in accordance with a contract or award with the Indian Health Service; or other public or private non-profit entities.

8. OVV Fiscal Year 2023 Research and Evaluation Initiative Solicitation –

The purpose of the Research and Evaluation (R&E) Initiative is to research and evaluate approaches to combatting domestic violence, dating violence, sexual assault, and stalking (hereafter referred to as “VAWA crimes”). By generating more knowledge about strategies for serving victims and holding offenders accountable, communities that benefit from VAWA funding will be better equipped to align their work with practices that are known to be effective, and they will be more capable of generating empirical knowledge on the efficacy of new and promising ways of doing things. The initiative is designed to support researcher-practitioner partnerships and a broad range of research and evaluation methods, including qualitative, mixed-method, quasi-experimental, and experimental designs. Because OVV has very limited funds to support research and evaluation, this initiative prioritizes topics for which a stronger evidence base would help OVV grantees use federal funds most effectively.

9. *****This is NOT a Funding Opportunity – There is a deadline to apply***** **Free Sign Language Interpretation Service for Victims Service Providers**

Activating Change is launching a new service that provides remote sign language interpretation services – free of charge – to victim service providers in the United States. Victim service providers must meet eligibility requirements and apply to participate.

About Our New Service

Activating Change’s Sign Language Interpreting Service for Deaf Victims closes the communication gap for Deaf victims of crime by providing qualified, trauma-informed remote sign language interpretation services – using safe and secure technology – free of charge to victim service providers serving Deaf victims of crime.

The service also provides expert guidance, tools, and resources to strengthen organization's capacity to effectively secure, prepare and work with sign language interpreters of different specializations, including Deaf Interpreters and trilingual interpreters.

Who Is Eligible

Any victim services organization in the United States is eligible to apply to participate in the service. However, priority consideration will be given to:

- Organizations with an immediate need for interpretation services
- Organizations in rural and remote communities
- Organizations in communities with limited to no sign language interpreters qualified to interpret in victim services
- Organizations that lack financial resources to pay for interpretation services

At this time, we cannot provide sign language services in the following settings:

- Law enforcement including initial response and victim interview
- Prosecution and courts
- Health care including forensic exams

How to Apply

If your organization is interested in receiving interpretation services from Activating Change, you will need to submit an online application. **Activating Change will begin accepting applications on Tuesday, June 13 and applications are due by Friday, July 7.**

10. OWW Fiscal Year 2023 Training and Technical Assistance Initiative Solicitation –

The primary purpose of the OWW Training and Technical Assistance Initiative (TA Initiative) (CFDA 16.526) is to provide direct training and technical assistance to existing and potential OWW recipients and subrecipients to enhance their efforts to successfully implement projects supported by OWW grant funds. OWW's TA Initiative is designed to strengthen and build the capacity of civil and criminal justice system professionals and victim service providers across the nation to respond effectively to domestic violence, dating violence, sexual assault, and stalking and foster partnerships among organizations that have not traditionally worked together to address these crimes.

11. BJA FY 23 The Price of Justice: Rethinking the Consequences of Fines and Fees –

With this solicitation, BJA seeks to fund a training and technical assistance provider (TTA), to work in partnership with five states, local, and/or tribal criminal justice agencies or systems ("jurisdictions") to address the use of fines and fees and ensure they are being imposed in a constitutional and nondiscriminatory way. The provider will work with sites to address common barriers to creating a more equitable justice system by addressing how sites use and apply fines and fees.

12. Support for 988 Tribal Response Cooperative Agreements –

The purpose of these cooperative agreements is to provide resources to improve response to 988 contacts (including calls, chats, and texts) originating in Tribal communities and/or activated by American Indians/Alaska Natives. With this program, SAMHSA aims to: (1) ensure American Indians/Alaska Natives have access to culturally competent, trained 988 crisis center support through existing and/or new 988 Lifeline centers; (2) improve integration and support of 988 crisis centers, Tribal nations, and Tribal organizations to ensure there is navigation and follow-up care; and (3) facilitate collaborations with Tribal, state and territory health providers, Urban Indian Organizations, law enforcement, and other first responders in a manner which respects Tribal sovereignty.

13. Affordable Connectivity Outreach Grant Program – Tribal Competitive Outreach Program (TCOP) Round 2 –

TCOP provides funding for outreach activities to increase awareness of and encourage participation in the ACP for households on Tribal Lands. This new funding opportunity for TCOP is intended to provide additional funding beyond the outreach-targeted grant awards announced by the Commission in March 2023. Additional outreach grant funding will allow targeted eligible entities to receive grant awards to conduct this necessary outreach to increase participation among those Americans most in need of affordable connectivity.

14. OJJDP FY 2023 Juvenile Justice Emergency Planning Demonstration Program for Juvenile Justice Residential Facilities –

With this solicitation, OJJDP seeks to support emergency planning for state, local, and Tribal juvenile justice residential facilities. For youth that reside in residential facilities it is crucial that applicants plan for and facilitate continued meaningful engagement with family and other supportive members of their community. Applicants are encouraged to ensure that these activities and strategies are prioritized in any emergency planning effort. Examples of ways that applicants could partner with youth and families includes establishing or utilizing an existing advisory group that includes family members of and/or youth that are currently or have previously been housed in the facility. These members could be involved in the drafting and reviewing of existing and new emergency planning procedures, to include evacuation strategies, and plans to ensure ongoing notification and communication procedures.

15. *Community Development Block Grant Program for Indian Tribes and Alaska Native Villages**

The primary objective of the Indian Community Development Block Grant (ICDBG) program is the development of viable Indian and Alaska Native communities, including the creation of decent housing, suitable living environments, and economic opportunities primarily for persons of low- and moderate-incomes. See the ICDBG regulations at 24 CFR 1003.2, the full text of which is available at 24 CFR part 1003.a. Single Purpose Grants. Projects funded by the ICDBG program must principally benefit low- and moderate-income persons (24 CFR 1003.208). These are competitive grants and are the subject of this NOFO.b. Imminent Threat Grants. Projects funded with Imminent Threat grant funds are to address issues that have an immediate negative impact on public health or safety of tribal residents. You do not have to apply for an Imminent Threat grant by the deadline established in this NOFO. These funds are awarded on a first-come first-serve basis until the amount set aside for this purpose is expended.

16. (deadline extended) OVV Fiscal Year 2023 Special Tribal Criminal Jurisdiction Grant Program – Solicitation

This program is authorized by the Indian Civil Rights Act of 1968 (codified as amended at 25 U.S.C. § 1304(h)(2)). The OVV Special Tribal Criminal Jurisdiction Grant Program (Tribal Jurisdiction Program) (CFDA# 16.025) supports tribes in their efforts exercise special Tribal criminal jurisdiction (STCJ) over non-Indians who commit “covered crimes” within the Tribe’s jurisdictional boundaries and provides technical assistance for planning and implementing changes in their criminal justice systems necessary to exercise the jurisdiction. “Covered crimes” are limited to assault of Tribal justice personnel; child violence; dating violence; domestic

violence; obstruction of justice; sexual violence; sex trafficking; stalking; and violation of a protection order. Grant recipients are committed to exercising the jurisdiction to ensure that victims find safety and justice and that non-Indians who commit covered crimes within their jurisdiction are held accountable.

New This Year

In the Violence Against Women Act Reauthorization Act of 2022 (VAWA 2022), Congress recognized the inherent authority of Tribes to exercise STCJ over non-Indians who commit an expanded set of “covered crimes.” In addition to domestic violence, dating violence, and violation of certain protection orders, these “covered crimes” now include: assault of tribal justice personnel (without requirement that victim be Indian), child violence, obstruction of justice (without requirement that victim be Indian or connection to covered crime), sexual violence, sex trafficking, and stalking. VAWA 2022 amended the statutory provisions governing the Tribal Jurisdiction Program to enable grantees to address all covered crimes.

Important Dates and Information

To submit an application, all applicants must register online with the System for Award Management (SAM) and with Grants.gov. To ensure sufficient time to complete the registration process, applicants should register online with SAM and with Grants.gov immediately, but no later than April 20, 2023.
